

**TRAVEL GUIDE** 



If you use a PAP device (CPAP, APAP, Bilevel) and need to travel for work or pleasure, you may wonder if there are any rules regarding traveling with and utilizing your PAP device. React Health is here to help you navigate flying with your PAP Device.

### Know Before You Go...

Empty your humidifier chamber before getting ready to travel with your Luna PAP Device. We recommend that you do not pack your PAP device in your checked luggage. Luggage can sometimes be delayed even when you have a direct flight or when your flight is on time. Carrying your Luna

PAP device in its carry case or in a carry-on will ensure that you have everything you need to sleep well when you get to your destination. Please remember to carry with you any needed documentation for your PAP device including, but not limited to:

- Your Prescription
- Letter certifying that your PAP device is compliant with FAA Regulations.

# Your PAP Device and TSA Security (US)...



The TSA.gov website provides this guidance for carrying your PAP device through security checkpoints in the United States

"A CPAP, BiPAP and APAP must be removed from it's carrying case and undergo X-ray screening. Facemasks and tubing may remain in the case. You may provide a clear plastic bag to place the device through the X-ray." (TSA.gov)

### Airlines and Baggage Policies...



Most U.S.-Based Airlines do not count a PAP device in it's carrying case as part of your carry-on baggage allowance. We recommend checking with your specific airline prior to flying to confirm individual airline's policies regarding

carry-on baggage.

## Using your PAP Device onboard the

### Aircraft...



If your airline allows the use of your compliant PAP onboard the aircraft:

» You should not rely on a working power port for your PAP device in

your seat

### Travel outside of the United States...



It is recommended that you contact your airline directly to discuss individual airline requirements. If you are traveling outside of the United States, please be aware that the power requirements may differ. The Luna

devices can be used with any standard electrical converter, but you will need to make sure you are bringing the proper adapter for the specific country you are traveling to. For patients using devices that have a humidifier, please be aware that tap water quality can vary greatly globally. React Health recommends the use of distilled water per the patient user manual for humidification.
